Article 1: General

The Participants may cooperate in the field of Technical Sciences and agree that mutual interest exists for establishing a long term technical, educational and scientific cooperation in accordance with the terms of this Memorandum of Cooperation (hereinafter referred to as the "Memorandum")

Article 2: Forms of Cooperation

This Memorandum is a general frame of the future cooperation in different forms:

- strengthening the contacts and dialog between participants,
- involvement of industry experts into educational process,
- providing student practice in duration of 30 days,
- providing a scholarship for Bachelor and Master Students,
- cooperation in defining the project themes and Bachelor, Master and Doctoral theses according to the industry needs,
- development of flexible study programs according to industry needs,
- cooperation on joint research, development and scientific projects, including within Erasmus+ programme,
- organizing of workshops, round tables, conferences and sharing the experience,
- organizing a training courses according to the industry needs, and issuing appropriate certificates,
- development of Life Long Learning courses according to industry needs,
- exchange of teachers and researchers.

Article 3: Implementation and Funding

The implementation of this Memorandum is subject to the laws and regulations of the country. Activities under this Memorandum are subject to the availability of financial resources. This Memorandum is not intended to be legally binding upon the participants and shall not be used as the basis for the creation of any legal claims.

All activities involving technical, educational and scientific cooperation which requires financial funding will be covered by legally-binding agreements, separate from this Memorandum.

The Parties agree that this memorandum does not cause any financial obligation between the parties.

Article 4: Intellectual Property


Should it become necessary, provision for the protection and allocation of intellectual property, created or furnished in cooperative activities under this Memorandum, should be set forth in a subsequent, legally-binding agreement, separate from this Memorandum.

Article 5: Commencement and Duration

Activities under this Memorandum may commence as of the date of signature and continue for a unlimited period, unless ended by the written notice from one of the participants, within a six-month period prior to such conclusion.
